BEFORE APPLICATION IS FULLY PROCESSED VENDOR MUST PROVIDE COPY OF EITHER A SINGLE EVENT OR MULTI-EVENT/YEARLY TEMPORARY FOOD FACILITY PERMIT. SUITABLE FOR TYPE OF FOOD BEING SOLD OR SAMPLED.

**CONFIRMATIONS & REFUNDS:** Confirmations will be mailed 7-10 days before the event. Any vendor who cancels will be charged a handling fee equivalent to 50% of their booth rental fee if before **July 15, 2011**. Beginning **July 22, 2011** booth fees are nonrefundable. There are no refunds in the case of inclement weather, acts of nature, or restrictions by government agencies to cancel the event, over which the producers have no control.

**OTHER:** The event producers reserve the right to limit the number of applications for any one type of good/service and relocate vendor spaces; for the good of the fair and its participants. No weapons, ammunition, alcoholic beverages, or drugs are allowed on the grounds. Vendors are prohibited from selling any firearms, ammunition, display/decor weapons, knives, or toy weapons of any kind.
